# I INTRODUCTION

Dear Colleagues,

This handbook provides information on a selected sample of postgraduate courses and research attachments available in the United Kingdom, in disciplines related to the broad areas of health services management and information systems. It is particularly addressed to well qualified candidates seeking opportunities for postgraduate study in the U.K. from the Czech Republic, Slovakia and other countries in central and eastern Europe which are the focus of the European Community PHARE programme. The entries here offer potential students information to decide which courses of study they might wish to consider in more detail. Fuller information may be obtained by approaching the appropriate institutions directly.

The focus is on longer programmes of postgraduate study, often associated with the award of higher degrees not the more experiential and typically shorter management development programmes which are a common feature of the training of health sector managers in Western Europe. The programmes included are focused on the health sector and so exclude the very wide range of Masters in Business Administration programmes addressed to managers across sectors, but usually biased towards commercial and industrial management. As well as health management and information systems, programmes in the related disciplines of epidemiology, health economics, health finance and public health medicine are included. All the programmes listed are taught in English.

The guide has been prepared from the response to enquiries in March 1993. It does not aspire to be comprehensive. Information on programmes offered by other Universities can be found in their postgraduate study prospectuses.

some respect from the listed courses or who have a time constraint. This is also true of some independent institutions, like the King's Fund College itself, which has a particular interest in developing the faculty for Czech and Slovak health sector management development centres. Interested applicants are invited to apply directly to the institutions of interest to them to explore feasibility, cost and funding.

Registration for a postgraduate degree or a research attachment requires that the student's initial qualifications are of an acceptable standard, normally at least the equivalent of a second class honours degree from a university in the United Kingdom in a field appropriate to the particular course of study or research.

It is essential that students should have an adequate command of English language. Candidates applying for a place at a United Kingdom institution of higher education may be required to obtain an acceptable score in an approved English Language Test. The following English Language tests are approved by all UK universities:

# FINANCIAL AID

It is almost impossible for an overseas student to obtain financial aid once he/she has arrived in the country where he/she intends to pursue further education. Candidates are therefore strongly advised to ensure, before leaving their home countries, that they have adequate funds available for the full duration of their studies. It is estimated that apart from academic fees, a student will need to allow approximately £6,500 to cover his/her living expenses per calendar year, that is, twelve months.

#### **EXISTING SCHEMES:**

Cambridge University Hospitality Scheme provides a grant for subsistence and book provision and free accommodation at a College in Cambridge for academics who wish to use the University's libraries and other facilities to further their research. This grant provides financial assistance for the duration of one month. The applicants must be teaching members of a University or Academy of Science Institute and be of post-doctorate status. There is no age limit. Application forms can be obtained from the British Council offices in Praha or Bratislava. This programme may be suitable for candidates wishing to pursue independent research in epidemiology.

Leverhulme Trust Post-doctorate Awards provide maintenance, external and internal travel allowances and academic fees for a 10 month research attachment to a British university. Applicants must be of post-doctoral status, be under the age of 35 and have been awarded a PhD in the last five years. This award is intended for

scholars in pure and applied sciences and medical research outside hospitals, e.g. epidemiology or public health. Further information may be obtained from local British Council offices.

T. G. Masaryk Scholarship Programme. Tenable at the University of London for a minimum period of 3 months and maximum period of 12 months, the scheme provides support for advanced and post-graduate research and study for Czech and Slovak graduates with leadership potential in their particular areas of work. Applications are invited from individuals currently working in government, the private sector, universities, or research institutes. The awards cover living expenses, academic fees and a contribution towards travel costs for short-term research attachments or for courses leading to formal qualifications such as Master of Science or Arts. Applicants for masters courses must be no more than 35 years of age. Application forms can be obtained from universities and other higher education institutions in the Czech and Slovak Republics, from the British Council in Praha or Bratislava or by contacting:

Oxford Colleges Hospitality Scheme supports Czech and Slovak scholars of appropriate distinction in their field of study to spend one month to further their research in libraries or scientific departments. The scheme provides free accommodation and subsistence but scholars must pay their own travel expenses. Application forms can be obtained from the British Council in Praha and Bratislava.

Training Awards Programme is directed at managers working in the public and private sectors in both the Czech Republic and Slovakia. The awards cover travel,

maintenance costs and academic fees. Applications should be made to the Know How Fund Unit at the British Council in Praha or Bratislava.

University of Warwick Scholarships for Eastern Europe provide support for scholars to undertake formal postgraduate courses or research programmes leading to PhD qualifications at the University of Warwick. Application forms are available at universities and other higher education institutions in the Czech Republic and Slovakia or may be obtained by writing to:

#### OTHER SOURCES OF FUNDING

Information about available scholarships can normally be obtained from the Ministries of Education and Health in the Czech Republic and Slovakia, from a representative of the British Council, the relevant country's Embassy or the European Community Delegation in Praha or Bratislava. Some long term and short term training may be supported through the many existing European Community programmes for example TEMPUS and PHARE. Sources of support include the British Government's Technical Cooperation Training Scheme, the World Health Organisation, one of the other specialised agencies of the United Nations such as UNICEF or ILO, and the World Bank. Some awards require nomination through the candidate's own government. Other sources which may be worth investigating are direct government assistance from the candidate's own country, his/her university, and some commercial and industrial firms.

#### MASTER OF SOCIAL SCIENCE PROGRAMME:

MSocSc Health Care Policy and Management.

#### Course content:

A programme tailored to the needs of students wishing to specialise in health care policy and management. The programme consists of two core courses: Advanced Health Care Policy and Health Care Management, plus an option chosen from a wide range of courses. The core courses focus on health care delivery, quality assurance, need and demand for health, measurement and determinants of health and public accountability. Other areas studied include health care planning and financing, clinical budgeting, information systems and performance indicators.

Duration: 12 months

#### Student profile:

Graduates from a variety of backgrounds relevant to health care policy.

#### Method of assessment:

Assessment is by 3,000 and 6,000 word extended essays, plus 10,000 word dissertation.

#### Entry requirements:

University degree at a standard equivalent to a British university upper second-class honours degree. Professional qualifications and work experience may be taken into account in appropriate cases.

English language test scores:

TOEFL 580 or IELTS 6

#### Cost:

Academic fees £5,550 approx.

#### SHORT COURSES:

The International Hospital Federation course for senior hospital and health service managers.

#### Course content:

The course offers an eight-week core programme of general management focusing on -human resources, planning and information, financial resources, performance and quality, problem solving and project management. The optional programme gives the choice of operational management, leadership or quality management.

<u>Duration</u>: 10 weeks; direct entry to the two-week options for those with previous management education.

#### Student profile:

Senior managers in any health profession.

A joint Health Services Management Centre and International Hospital Federation certificate on completion of the course.

#### Method of assessment:

Suitable applicants can register for a University of Birmingham Postgraduate Certificate in Health Management. Details available on request.

#### Entry requirements:

Applicants are senior professionals with experience of management, an excellent command of English language and are typically between 30-50 years old.

#### MASTER OF SCIENCE PROGRAMME:

MSc/Diploma Community Health.

#### Course content:

The aim of this course is to provide students with knowledge and skills of the public health sciences so that they are able to define, critically assess and resolve public health problems. This course is equivalent to a Master of Public Health (MPH) degree. By using the range of elective modules available, the course is equally suitable for participants with a career with emphasis on research methods (epidemiology, medical statistics and evaluation) or whose future lies in public health practice.

Duration: 12 months

#### Student profile:

Medical graduates or non-medical graduates preferably with two years' relevant postgraduate experience.

#### Method of assessment:

Course work, written examinations and a thesis.

#### Entry requirements:

University degree in medicine or non-medical graduates with appropriate postgraduate experience.

#### Course content:

The aims of this course are to introduce the concepts underlying health promotion theory and practice, to identify the scope and purpose of health promotion including health education, prevention and health protection, to provide opportunities for critical review and analysis of current approaches in health promotion, and to enable students to acquire knowledge, skills and attitudes necessary to plan, implement and evaluate health promotion activities and research.

**Duration:** 12 months

#### Entry requirements:

#### MASTER OF SCIENCE PROGRAMME:

MSc Health Services Research.

#### Course content:

The main objective of the course is to provide students with skills necessary to health services decision-making through taught courses which include research methods, management information and decision support systems, health administration, and health policy. Instruction is provided not only by academics of the University but also by health service practitioners.

Duration: 12 months

#### Student profile:

Graduates with varied professional backgrounds who are working, or intend to work, in the area of health policy either at governmental, regional or district levels, or who are academics and researchers in higher education institutions.

#### Method of assessment:

Course work, written examination and a research project.

#### Entry requirements:

Relevant university degree at a standard equivalent to a British university second class honours degree.

English language test scores:

TOEFL 600 or IELTS 6

Cost:

Academic fees - £5,500

#### HEALTH SERVICES MANAGEMENT TRAINING PROGRAMME:

Diploma in Health Services Management (DipHSM)

#### Course content:

Designed specifically to meet the basic management training needs of public and private sector health service personnel who wish to enhance their skills and consolidate their experience, the twelve course modules are arranged into three groups: background skills and the environment of health services; the organisational context of health services management; management skills and organisational functions. Instruction is provided by University staff and health service practitioners and the programme is jointly managed by University and Health Authority representatives.

Duration: 24 months part-time

#### Student profile:

Applicants normally are employed in a management or supervisory position in the health care/services field e.g. as ward managers, unit managers, service co-ordinators. The standard requirement is that they should have either a degree or a professional qualification of equivalent standard.

#### Method of assessment:

Each of the twelve modules is assessed by a specific course assignment such as an essay, a report, a small project. Credits are awarded for each successfully completed module and these are accumulated by those wishing to qualify for the Diploma. Exceptional candidates may be exempted from certain modules by furnishing evidence for consideration for APL (Accreditation of prior learning).

#### Entry requirements:

Applicants must satisfy the programme's joint managers as to their fitness to undertake the course of training. Normally they should have (a) a degree or (b) a professional qualification or (c) appropriate professional experience and be currently employed in a management/supervisory position in the health services field.

TOEFL 600 or IELTS 6

Academic fees £1,800

#### HEALTH SERVICES MANAGEMENT TRAINING PROGRAMME:

Health Services Management Modules (Credited)

#### Module content:

Each of the twelve modules of the DipHSM can be taken separately as a free-standing short course or as part of the MSc Health Services Research. The following modules are available: The Environment of Health; Economics of Health; Research and Statistics for Health Service Managers; Law and the Health Services; Finances, Resource Allocation and Budgeting; Business Planning and Contracting; Managing Relations between Agencies; Human Resources and Health Care; Information Management and Audit; Managing Change; Managing People; Personal and Professional Development.

Duration: 6 to 8 weeks per module

#### Student profile:

People employed in a management or supervisory capacity in the health care/services field.

#### Method of assessment:

Each module is assessed by a specific course assignment such as an essay, a report or a small project. Credits may be awarded for each successfully completed module.

#### Entry requirements:

Normally candidates should have (a) a degree or (b) a professional qualification or (c) appropriate professional experience and be currently employed in a management/supervisory position in the health services field. MSc Health Services Research students may, subject to special permission from the course Director, take one or more of the modules as part of the MSc course.

MSc Health Planning and Financing.

#### Course content:

A combination of subjects from medical, epidemiological and social science programmes which enables students to develop knowledge and expertise in the disciplines required to formulate health policies and for planning, financing and managing the health sector. 

# Better MANAGEMENT Better HEALTH

The health sector management project was the first investment by the European Communities PHARE programme in supporting the transformation of health services in the Czech Republic and Slovakia. Between April 1992 and April 1993 the project provided initial technical assistance in developing health sector management and information systems. Its aims have been to work with managers in the two Republics in seeking to understand the challenges of achieving radical transformation in national health systems; support these managers through on-site consultancy and a range of training opportunities; and use this experience to identify ways of strengthening the incountry capacity for management and information systems development in 1993 and beyond. The project has been undertaken by the King's Fund College, London in collaboration with the Instituto de Estudios Superiores de la Empresa, Barcelona and the South East England Institute of Public Health.
